

Return to Play SPECTATOR PROTOCOLS



The following information provides direction for schools in accordance with health guidelines for school sponsored athletics and activities. These protocols have been adopted by Alpine, Canyons, Granite, Jordan, Murray, Provo, and Salt Lake City school districts. For the safety of spectators, athletes, coaches, their families, and the community at large, **these guidelines must be followed.**

Please be aware that guidelines may be adjusted during the school year by the health department and government officials.

TICKETED EVENTS

- School officials will determine the capacity of their home venue seating and may sell 25% of the capacity to spectators. Athletes, cheer, band, and school supervision do not factor into the 25% unless they are in the bleachers. Two tickets per athlete is recommended for parents.
- School officials will also determine the capacity of their venue's visitor seating and will work with the visiting school to sell tickets for 25% of the seating capacity in the visitor section for spectators.
- All ticket purchases must be done in advance via electronic (VNN/Go Fan/Hometown Ticketing/Ect.) touchless system or out of the main office. Same day ticketing will **NOT** be sold at the game/event.
- A spectator agreement form is required for spectators. The form must be signed before an individual can purchase tickets.

NON-TICKETED EVENTS

Gymnasium, stadium, and auditorium use will follow the same capacity guidelines as ticketed events. The school may limit capacity by issuing electronic no-cost tickets, or have another plan to limit capacity. At all other non-ticketed events, including sophomore and JV games, spectators are required to wear masks when entering and exiting the event and may only remove the mask when physical distancing is possible.

Spectators at non-ticketed events will sign the Spectator Agreement Form. This would preferably be accomplished at the required parent meeting before the season. School officials will enforce wearing masks and physical distancing for students at school events, and ask the public to adhere to these guidelines.

SPECTATOR AGREEMENT FORM

Spectator Agreement Forms (see reverse side) will be signed by students and parents before attending extracurricular events. It is expected that fans of visiting schools will have signed an agreement form at their home school for events both home and away.

Guidelines and Expectations

- The following state guidelines for Public Health Risk Level (current risk color level as of today) including but not limited to the following:
 - When outdoors, spectators will be expected to wear masks when entering and exiting a venue and when a physical distance of at least six feet is not feasible.
 - Spectators will be expected to wear masks while attending indoor events.
 - Spectators will maintain physical social distancing wherever possible.
 - Spectators will not attend an event if exhibiting any symptoms (fever, cough, shortness of breath, sore throat, sudden change in taste or smell, muscle aches or pains, close contact with someone who has tested positive for COVID-19).
- All ticket purchases must be done in advance via electronic system or out of the main office. Same day tickets will **NOT** be sold at the game/activity.
- Wrist bands, electronic tickets, or paper tickets for spectators are required for entrance - no money will be taken at the door/gate.
- Be aware that cancellations of games may occur at any time due to concerns with COVID-19.
- Only 25% of stadium/gym/field's capacity may be filled by spectators. This will be determined by schools based on their individual facilities. Schools will limit the number of spectators accordingly for both home and visiting spectators.
- All spectators will adhere to proper social distancing protocols. Spectator compliance will be evaluated after every game/activity to determine future admission.

By signing below, I understand the above rules and expectations as a condition for attendance at this event, and I recognize that failure to adhere to these expectations may jeopardize my opportunity to attend future games/activities.

I also recognize that in a group setting I may be exposed to COVID-19. I acknowledge that my attendance is voluntary, and I assume all risk associated with this possible exposure.
